

1 Wiring



There is one network interface, one alarm in interface and one 12 V DC power interface on the rear panel of the indoor station.



- You can power on the device via the power interface with 12 V DC power supply. Or you can power on the device via standard PoE through the network interface.
- For DS-KH6110-WE1 and DS-KH6100-E1, by default, AIN1 is for doorbells, AIN2 is for smoke detectors, AIN3 is for gas detectors and AIN4 is for active infrared detectors; For DS-KH6000-E1, by default, AIN1~AIN4 are for doorbells.
